



**Town of Grafton Ordinance No. 2012-03**

**AN ORDINANCE AMENDING  
TITLE 2, GOVERNMENT AND ADMINISTRATION, CH. 2, TOWN MEETING, OF  
THE CODE OF ORDINANCES, TOWN OF GRAFTON, WISCONSIN,  
TO CONFORM WITH 2011 WIS. ACT 115 AMENDMENTS TO WIS. STAT. CH. 60**

**WHEREAS**, Wisconsin law previously provided that the Annual Town Meeting was to be held on the 2<sup>nd</sup> Tuesday in April, pursuant to WIS. STAT. § 60.11(2); and

**WHEREAS**, Wisconsin law has been amended to provide that the Annual Town Meeting shall be held on the 3<sup>rd</sup> Tuesday in April; pursuant to 2011 WIS. ACT 115; and

**WHEREAS**, it is deemed to be in the best interest of the Town of Grafton that the Municipal Code of the Town of Grafton be further modified and amended to conform to the same; and

**WHEREAS**, a Notice of Public Hearing before the Town Board was duly published in the *Ozaukee Press* on \_\_\_\_\_, 2012 and \_\_\_\_\_, 2012; and

**WHEREAS**, a Public Hearing was held before the Town Board on \_\_\_\_\_, 2012 regarding the proposed Amendments to the Town's Code of Ordinances;

**NOW, THEREFORE**, the Town Board of the Town of Grafton does hereby ordain as follows:

Section 2.2.3 of the Town of Grafton Code of Ordinances is hereby amended as provided below by adding the underlined language and deleting the language struck out:

**2.2.3 Annual Town Meeting.**

...

**2.2.3.02 When Held**

- (A) Except as provided in Subsection 2.2.3.02(B) below, the Annual Town meeting shall be held on the ~~second (2nd)~~ third (3rd) Tuesday of April.
- (B) The Annual Town Meeting may set a date different than provided under Subsection 2.2.3.02(A) above for the next Annual Town Meeting if the date is within ten (10) days after the ~~second (2nd)~~ third (3rd) Tuesday of April.

This ordinance shall be effective upon publication or posting by the Town Clerk as required pursuant to WIS. STAT. § 60.80.
